

Dear Applicant:

Thank you for your interest in seeking support from Red Canoe Foundation. We understand the unparalleled benefits for kids that travel in the wilderness provides. Red Canoe Foundation — a not-for-profit, U.S. 501(c)(3) — was founded to support wilderness organizations committed to providing this opportunity, in part by increasing youth participation through camper scholarships.

Scholarships are offered to applicants (age 10-19) based on two criteria: (1) demonstrated financial need for support (evidenced by the submission of specific tax forms); (2) merit-based qualifications based on written submissions by applicant and parents/guardians. Red Canoe Foundation will accept applications from all of those in financial need regardless of race, creed, color, sex, age, national origin, disability, or sexual orientation.

Please submit a complete application at your earliest convenience and no later than February 28, 2022. Please be advised that Red Canoe Foundation's ability to provide an award may be constrained by the number of requests it receives. Requests for and notifications of support will follow this schedule:

- Applications received by December 31, 2021, will be notified of award availability and amount by January 15, 2022.
- Applications received January 1-February 28, 2022, will be notified of award availability and amount by March 15, 2022.
- Applications received after February 28, 2022, may be considered on a rolling basis depending on available resources.

For an application to be considered complete, Red Canoe Foundation must receive all of the following via email to [gcoleman@redcanoefoundation.org](mailto:gcoleman@redcanoefoundation.org):

1. a completed scholarship application form (Section A);
2. a copy of current year's W2 form and any other income-reporting forms such as 1099s, with social security numbers redacted, for any parent or guardian who claims the applicant as a dependent (Section B);
3. a letter of recommendation from a non-family member (e.g., teacher, coach) (Section B);
4. a thorough response by a parent/guardian to the question listed in Section C; and
5. a thoughtful response by the applicant/camper to the two questions listed in Section C.

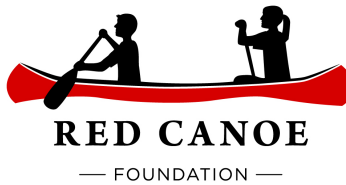

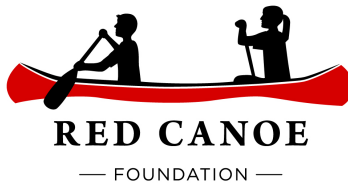
